- 3. Location:** Chisholm Trail Technology Center, 283 State Highway 33, Omega, OK 73064 (13 miles east of Watonga, OK or 16 miles west of Kingfisher, OK.)
- 4. Operation:** CTTC agrees to operate and conduct the school in accordance with rules for Commercial Driver Training, Department of Public Safety.
- 5. Motorcycles:** CTTC maintains a fleet of motorcycles to be utilized by the Basic RiderCourse<sup>SM</sup>. Participants.
- 6. Attendance:** **100%** participation and attendance is required. Student completion is at the discretion of the instructor(s).
- 7. Contract:** This instrument contains the entire contract between parties and no changes or amendments thereto shall be binding upon the parties, unless made in writing.

**Note:** All motorcycle *RiderCourses<sup>SM</sup>* require the operator have proper riding gear, which includes **helmet, eye protection, full-fingered rider gloves, long-sleeve shirt or jacket, long pants and over the ankle boots.** Gear must be worn at every session. (boots with leather soles are not recommended.) **No student will be allowed to ride any portion of the course without all of the listed items.**
